### **Freight Terms:**

Standard Catalog Products orders delivered to the contiguous states West of the Mississippi River, which amounts to over \$7,500.00 will be shipped via best way in one shipment by common carrier and the freight charge will be prepaid (freight allowed) by ELA. Standard Catalog Products orders delivered to the contiguous states East of the Mississippi River, which amounts to over \$10,000.00 will be shipped via best way in one shipment by common carrier and the freight charge will be prepaid (freight allowed) by ELA. Additional freight charges will be the responsibility of the customer for special instructions and services such as, but not limited to: re-consigned, residential deliveries, lift gate deliveries, specific hours of delivery, call before delivery requests, and storage charges. Such charges will be invoiced to the customer by ELA. All packaging will be suitable for domestic carriers. Consult the factory for special handling, packaging, and export requirements. Freight prepaid by ELA is conditional upon the payment terms of the order acknowledgment being met (net 30 days). All custom product will be shipped freight prepaid and add, and will be billed to the customer accordingly. All will call items will be susceptible to local sales tax.

### Freight Claims:

All shipments will be FOB origin. Ownership of the goods passes to the buyer as soon as they leave the factory. Freight claims are the responsibility of the customer receiving the goods. All damages concealed or otherwise, must be handled by the receiving party with the delivering carrier. ELA will not accept claims for any order with FOB origin terms. In the event the merchandise is defective the claim must be made to ELA within two (2) days (48 hours)upon delivery.

#### Maintenance:

Wipe fixture's external components with clean water with minimal amounts of mild soap. Wipe lens with dust free non abrasive micro-fiber towel or blow with compressed air not exceeding 20psi. A maintenance record indicating date, type of maintenance performed, and person performing the maintenance. Regular maintenance must be performed as part of the warranty policy.

#### Returns, Repairs, and/or Back Charges:

ELA is not obligated to consider requests to accept returned merchandise; except for merchandise shipped by error. All returned goods must be accompanied by a "Return Material Authorization" (RMA), which can be obtained only from the ELA factory. Requests to return material must be made in writing within 90 days from the date of shipment and must show the ELA invoice or order number, the date of shipment, and quantities of designated items that are desired to be returned. Returned merchandise must be new and in its original ELA factory sealed carton. Credit will be considered for only the actual quantity received by ELA. Minimum restocking fees will be 35% for standard showroom lighting fixtures and 50% for all other standard items along with any outbound freight charges originally paid by ELA. Product to be returned must be returned freight prepaid within 30 days after the issuance of the RMA. Again, no item will be accepted without a RMA. All merchandise is subject to inspection; and additional reconditioning charges will be assessed for any damages incurred. Ballast/drivers and other electrical devices incorrectly ordered by the customer, including but not limited to, voltage, mode, and current are non returnable. Should any electrical devices be returned to the factory they must be complete and unaltered. If lead wires are cut or any other alteration has been made, credit will not be allowed. Modified, Custom, and made to order products; as well as poles or discontinued catalog items are not returnable for credit under any circumstances. ELA does its best to provide quality product.
